5 The number of days that Mr. Romney says the United States government knew about the terrorist connections to the attack in Benghazi, Libya

\$6,400 The additional amount Mr. Obama says individual beneficiaries would pay if Mr. Romney and his running mate, Representative Paul D. Ryan of Wisconsin, enacted their plans for reforming Medicare

"NO. 1" Where Russia ranks on the list of America's most important geopolitical foes, according to Mr. Romney

23 MILLION The number of Americans who are, in Mr. Romney's vernacular, "unemployed, underemployed or have stopped looking for work.

46.2 MILLION AND 15 MILLION The number of people in poverty and the growth in the number of people on food stamps.

47TH Where Massachusetts ranked in job creation during Mr. Romney's tenure as governor.

- **\$17,000** The amount that Mr. Romney says he might cap deductions after lowering income tax rates.
- **4** The number of Supreme Court justices older than 70, who might be candidates for replacement by the next president.
- 2 The number of years of tax returns that Mr. Romney has released.
- **12** The number of years of tax returns that George Romney, Mr. Romney's father, released when he was running for the Republican presidential nomination in 1968.
- \$2,000 The amount that Mr. Obama says middle-class taxes will go up if Mr. Romney is elected.
- **30** The number of months in which the country had added private-sector jobs.
- **11 MILLION** The number of illegal immigrants already in America.
- **14.1 PERCENT** The rate that Mr. Romney paid on his federal tax returns during the past two years
- **3.80** The average price of a gallon of gas.
- **20 PERCENT** The size of the across-the-board tax rate cuts that Mr. Romney promises if he is elected.
- **47 PERCENT** The now-famous proportion of the public that Mr. Romney said were "dependent" on the government and viewed themselves as "victims." The president's campaign has seized on the comments from secretly recorded remarks as evidence of Mr. Romney's true feelings toward the less well off. He will no doubt cite it frequently.
- **1.3 PERCENT** The United States' economic growth in the second quarter, revised down from an already paltry 1.7 percent
- **12 MILLION** The number of new jobs that Mr. Romney promises his economic plan will deliver during his first term.
- **8.1 PERCENT** The unemployment rate. Probably the most frequently cited number in the 2012 presidential campaign. Mr. Romney cites it as evidence of the president's persistent failure to confront a sluggish economy. Mr. Obama counters by citing more than two years of positive job growth.
- **\$4,000** The amount that middle-class families will be taxed because of Mr. Obama's economic policies, according to Mr. Romney.
- **\$16,000,000,000** The amount of United States debt. Mr. Romney has tried repeatedly to get people focused on the country's \$16 trillion debt after four years of an Obama presidency.
